Food Booths are available at \$400.00 \_\_\_\_\_ Electricity available (110 volt) Hook up fee is \$50.00. **YOU MUST SUBMIT MENU!** Each food vendor will be required to obtain their own Orange County Health Department permits and provide a copy to Dana Point Chamber of Commerce at least **TWO WEEKS** prior to the event. No private generators allowed.

The **2008 Street Faire will be held RAIN or SHINE and there will be NO REFUNDS or alternate dates. You must protect your own property from damage due to weather, public, etc. EVENT HOURS** are 10:00AM until 5:00PM each day. Grounds open at 6:30AM. Clean up by 6:00PM. Cars are **NOT** permitted on the grounds before 5:00PM. If area is not cleaned up by 6:30PM there is a penalty fee of \$50.00.
